THIS PROJECT INCLUDES A "FISH ELEVATOR" TO HELP THEM GO UP STREAM AND A TUBE OR "WATERSLIDE" TO HELP THEM RETURN DOWNSTREAM. THIS PROJECT HAS REMOVED TWO BARRIERS TO UPSTREAM PASSAGE AND OPENED UP 21 MILES OF THE MENOMINEE RIVER TO ALLOW LAKE STURGEON TO TRAVEL TO THEIR SEASONAL SPAWNING, WINTERING, AND FORAGING HABITATS.
